### 2026 Residential Roof of the Year

### **Judging Criteria**

The Residential Roof of the Year Award recognises outstanding workmanship, technical execution, and professional roofing practice on a residential project completed by a RANZ Member company.

Judging is based solely on the written project summary, product/system information, and up to five submitted images. No site visits are conducted.

Eligible projects must have been completed between 1 April 2025 and 31 March 2026.

### **Judging Categories**

#### 1. Workmanship & Technical Execution

Judges assess the quality and accuracy of the roofing installation.

- Cleanliness, consistency, and precision of visible roofing details.
- Quality execution of flashings, penetrations, hips, ridges, valleys, and junctions.
- Evidence of best-practice installation aligned with NZ standards and industry expectations.
- · Overall finish as demonstrated in submitted images.

#### 2. Complexity & Technical Challenges

Recognises the difficulty of the project and how well the team delivered it.

- Level of complexity due to design, pitch, geometry, access, or environmental constraints.
- How technical challenges were approached and resolved.
- Innovation or problem-solving visible in the project process.
- Clear demonstration of skilled roofing practice under demanding conditions.

#### 3. Craftsmanship & Visual Outcome

Assesses the quality of the finished roof as a completed piece of workmanship.

- Visual alignment, straightness, and overall appearance.
- Fit and finish of details that demonstrate exceptional craftsmanship.
- How the roof complements the residential structure.
- Evidence of pride in the final presentation.

Note: This category focuses on roofing execution, not architectural design.

#### 4. Material Selection & System Suitability

Evaluates whether the products and systems used were appropriate for the job.

- Suitability of materials for the building type, location, and design.
- Integration of the roof system with flashings, underlay, substrate, and other envelope components.
- Demonstration of understanding of product performance requirements.

#### 5. Project Story, Professionalism & Documentation

Assesses the clarity and completeness of the submission.

- Quality and detail of the 200-word project summary.
- Clear explanation of challenges, solutions, and team approach.
- Professionalism in how the project is presented.
- Quality, relevance, and clarity of the attached images.

#### **General Judging Notes**

- Judging is completed in one round with no site visits.
- The panel can only assess the information and images supplied.
- Entries lacking sufficient photographic evidence may score lower.
- Home owner statements are not mandatory but may support the overall impression of project quality.
- Judges assess the roofing company's workmanship and approach—not the architectural merits of the home.
- All decisions by the judging panel are final.
